Rules and Requirements

Qualifying Customers

 The Compressed Air Efficiency program is available to Xcel Energy electric business customers in Colorado that purchase and install qualifying No Loss Drains or factory integrated Variable Frequency Drive (VFD) Compressors between 10 and 49 horsepower.

No Loss Air Drain Rules

- 1. Xcel Energy offers a cash rebate of \$200 per new no loss air drain.
- Drains on inlet modulation or load/no load systems with < 2 gal/CFM storage are not eligible.

Compressor Rebate Rules

Xcel Energy offers a cash rebate starting at \$1,000 and up to \$7,000 to customers for VFD Compressors (10hp – 49hp):

Compressor Size	New Capacity, or Restoral of non-working compressors	Early Replacement (of a working load/no-load or modulation compressor)*
10 HP	\$ 1,000	\$ 4,000
15 HP	\$ 1,500	\$ 4,500
20 HP	\$ 2,000	\$ 5,000
25 HP	\$ 2,500	\$ 5,500
30 HP	\$3,000	\$ 6,000
40 HP	\$ 4,000	\$ 7,000

System Requirements for all systems:

- 1. Equipment must be a new, rotatory type compressor with factory installed VFDs (Piston or reciprocating compressors do not qualify).
- 2. The equipment must be in service (not backup).
- 3. The total system must be less than 50 hp.

System Requirements for Early Replacement Rebates:

The new compressor must replace old compressor(s) that satisfies all of the following:

- Load/unload compressor with less than two gallons of storage per CFM of compressor-rated capacity.
- Modulator compressor with or without blow down.
- Of equal or greater size than the new compressor.

Custom Efficiency rebate program

Any compressor over 10hp that does not meet the above qualification rules, as well as any other energy saving measures, may be submitted for analysis under the Custom Efficiency program. The Custom Efficiency program requires preapproval before the equipment is purchased.

Additional Rebate Rules

- Installation must be complete before submitting rebate application.
- Customers must submit their rebate application for rebates within 12 months from the purchase date on the invoice.

- A copy of a dated invoice and manufacturer's equipment specification sheet must accompany the rebate application. Please make sure that the supporting equipment information (model number) matches the rebate application.
 - The customer invoice must show quantity, model number, and hp.
 - The manufacturer's specification sheet must show: manufacturer, model number, nominal efficiency %, horsepower and rpm. Xcel Energy may confirm specifications to determine eligibility and rebate amounts.
- Rebates will not exceed 60% of the project cost. Xcel Energy will issue a rebate in the form of a check, not a utility bill credit.
