

Rebate details

Xcel Energy issues cash rebates in the form of checks, not utility bill credits. Xcel Energy is not responsible if your contractor provided inaccurate information about the amount and/or conditions of the actual rebate or equipment eligibility.

Application details

Account holder applications must be postmarked no later than July 31 of the year following installation of qualified equipment.

Applications must include complete contractor information and information about the equipment including: size or capacity, make, model number, serial number and efficiency rating.

No phone calls will be accepted to provide verification of this information.

A copy of the dated sales receipt or invoice with specific equipment must accompany complete information on the front of this form.

Xcel Energy reserves the right to refuse payment and participation if the account holder or contractor violates program rules and procedures. Xcel Energy is not liable for rebates promised to account holder as a result of a contractor misrepresenting the program.

All information on the receipt or invoice must precisely match the information on the rebate application or the application will be returned.

We reserve the right to conduct random inspections to verify installation of the rebated equipment at the address indicated on the front of this form. Your assistance is appreciated.

Limitations

Rebate qualifications and amounts are subject to change anytime. Our rebate programs may be cancelled with 30 days notice.

Special promotions

During special promotions for this program, it is the account holder/contractor's responsibility to ensure all paperwork is postmarked by the deadline. Promotional rebate amounts will be automatically calculated by Xcel Energy.

Help with forms

If you are building a new home, you must obtain a sales receipt for the equipment from your builder or retailer. Only one rebate per piece of equipment will be paid.

If you have questions while filling out this form, please contact your contractor for assistance. Please allow up to eight weeks for your rebate to arrive. You can call 800.895.4999 for status of your application.

Qualifying account holders

Xcel Energy natural gas residential account holders are eligible for qualifying, high-efficiency furnace rebates.

Xcel Energy electric use residential account holders are eligible for the ECM (Electronically Commutated Motor) rebate.

Rebates for new home construction should be negotiated between the builder and resident or new home buyer to determine who receives the rebate.

Participants understand they are not eligible to receive additional rebates for this improvement through a different Xcel Energy Rebate program.

Account holder equipment must be purchased from and installed by a contractor who is currently registered with Xcel Energy's Heating program, as listed on xcelenergy.com/cotrades.

Customers may receive both a furnace and an ECM rebate.

Efficiency ratings are determined by the Air Conditioning, Heating, and Refrigeration Institute (AHRI). **Only equipment listed on the AHRI site (ahridirectory.org—residential section only) is eligible for rebate.** Submitting an AHRI certificate with your application and invoice is highly recommended. The AHRI list of qualifying equipment changes frequently. AHRI certificates that are printed and sent in with the rebate application will be honored even if the equipment is no longer listed on the website. If more than one unit is installed at an address, one rebate form per unit is required to receive a rebate for each unit.

Electronically commutated motors (ECM) rebate

An Electronically Commutated Motor (ECM) powers the fan that moves air through the centralized heating and/or cooling system. ECMs will be validated via Original Equipment Manufacturer (OEM) specification sheets or OEM websites. Submitting an OEM spec sheet with this application is encouraged. Customers who purchase a non-qualifying furnace that includes a factory-installed ECM may receive the ECM rebate. Customers who purchase a new ECM to add to an existing forced air gas furnace may receive the ECM rebate.

Note: Local, state or federal tax credits or rebates may also be available for energy-efficient home improvements. Ask your tax advisor or visit energystar.gov.
