The principal purpose of this filing is to implement portions of the Company's Colorado P.U.C. No. 6 - Gas tariff to go into effect on November 1, 2022 in compliance with the Decision.¹ This advice letter will place into effect the base rate revenue increases and associated rates for the Company's

natural gas customers effective November 1, 2022, as well as certain tariff language changes as authorized by the Decision.²

Pursuant to the Decision, the Company is required to make a compliance filing on not less than two business days' notice.³ It is desired that the tariffs accompanying this Advice Letter become effective on November 1, 2022, in compliance with the Decision.

² The Commission's approval of the Company's proposal to combine Schedule IG (Interruptible Sales) and Schedule TI (Interruptible Transport) as one "Interruptible General" class for purposes of the Class Cost of Service Study (Decision at ¶¶249-251) does not require creation of a new, single tariff rate schedule applicable to both sales and transport interruptible customers, which was not proposed by any party in the case. For purposes of this compliance filing, the Company maintains the separate Schedule IG and Schedule TI tariffs, along with their separately approved rates and tariff changes. In addition, note that revisions to Tariff Sheet No. 50A as proposed by the Company (which was to the Company's knowledge not disputed and, therefore, approved), included the following verbiage: The Deferred costs will be offset by Unauthorized Overrun Penalties and Unauthorized Overrun Penalties collected from customers. The inadvertent and duplicative first reference to "Unauthorized Overrun Penalties" has been removed as part of this compliance filing so that the verbiage correctly reads: The Deferred costs will be offset by Unauthorized Overrun Penalties collected from customers.
