NOTICE OF PROCEEDING AND HEARING

NOTICE is hereby given of the following matters pending before the New Mexico Public Regulation Commission ("NMPRC or Commission"):

On July 23, 2019, Central Valley Electric Cooperative, Inc. ("CVEC") and Southwestern Public Service Company ("SPS") filed a Joint Application and supporting direct testimony with the Commission requesting the Commission enter a Final Order approving the voluntary service agreement ("Boundary Agreement") entered into by CVEC and SPS on June 20, 2019.

The Boundary Agreement defines and establishes proposed service areas for CVEC and SPS in specific portions of Eddy and Lea Counties, New Mexico, and defines the arrangements and requirements for electric service provided by each utility within its proposed service area and for service authorized in the other utility's service area. Specifically, the Boundary Agreement:

- (a) defines and establishes proposed service areas for CVEC and SPS in portions of Eddy and Lea Counties, New Mexico;
- (b) authorizes CVEC and SPS to serve existing and expanded customer loads and new loads in the proposed service areas;

- (c) identifies the location of distribution lines within each utility's proposed service area that extend into and currently serve loads in the other utility's service area;
- (d) authorizes CVEC and SPS to continue to maintain and operate their existing facilities that serve existing customer loads in the other utility's proposed service area, subject to the requirements and limitations established in the Boundary Agreement; and
- (e) establishes requirements to be followed by CVEC and SPS in addressing customer requests for new or expanded service (i.e., accounts/meters) from their respective facilities.

Pursuant to NMSA 1978, Section 62-9-7(B), the Commission may, after public hearing upon at least twenty days' notice, approve voluntary service agreements between utilities providing similar service proposing the delineation between themselves of one or more service areas in which each shall be entitled to furnish service, if the Commission first determines that the proposed delineation of service areas is consistent with the public convenience and necessity and otherwise conforms to the Public Utility Act.

Further information can be obtained by contacting CVEC, SPS, or the Commission at the addresses and telephone numbers provided below. The Commission has assigned Case No. 19-00211-UT to this proceeding and all inquiries or written comments concerning this matter should refer to that case number.

- (B) Testimony shall be filed by Staff, and may be filed by the interveners, by October 11, 2019.
 - (C) Any rebuttal testimony may be filed by October 21, 2019.
- (D) A public hearing will be held on November 7, 2019, starting at 9:00 A.M. in the Ground Floor Hearing Room of the Commission in the P.E.R.A. Building, 1120 Paseo De Peralta, Santa Fe, New Mexico, to hear and receive testimony, exhibits, arguments and other appropriate matters relevant to this proceeding.

The procedural dates and requirements currently set in this case are subject to further order of the Commission or the Hearing Examiner. Interested persons should contact the Commission at 505-827-6956 for confirmation of the hearing date, time, and place, since hearings are occasionally rescheduled.
