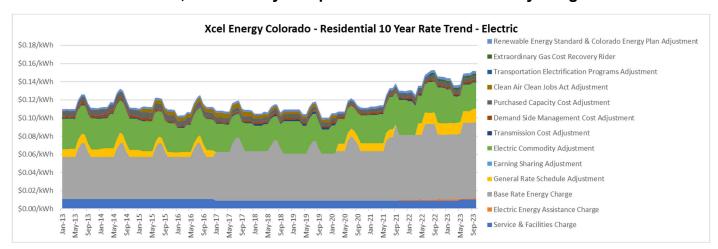

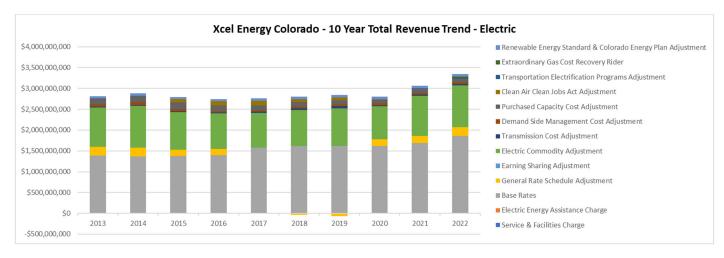

The annual change in revenue was calculated as if the current TCA and the proposed January 1, 2024 TCA had been in place for a full calendar year, and is illustrated above to compare changes to annual revenues. The revenue requirement for the rates effective September 8, 2023 – December 31, 2023, resulting from the electric rate case, Proceeding No. 22AL-0530E, was \$14,840,750.

In the preceding figure the fixed monthly charge is presented as a cents per kilowatt charge and is calculated by dividing by average customer usage over the year.



Public Service has included the ten-year history of total revenues in response to paragraph 39 of Commission Decision No. C23-0538 which clarified that "annual total amount" is best represented by annual revenues collected.
