The principal purpose of this filing is to change the Gas Affordability Program (“GAP”) enrollment terms to ensure that income qualified customers remain enrolled in the program for a minimum of 12 months to receive 12 months of benefits. The Company is simultaneously filing a separate advice letter with similar requests as related to its Electric Affordability Program.

The Company is not seeking a GAP funding increase or decrease. This filing has no net effect on the Company’s annual revenues.

The Company is filing a Motion for Alternative Form of Notice herewith, seeking to provide notice to our customers by the means set forth therein.

It is desired that the changed tariffs accompanying this Advice Letter become effective on May 16, 2024, on 30-days’ notice.


