The principal purpose of this filing is to change the Electric Affordability Program ("EAP") enrollment terms to ensure that income qualified customers remain enrolled in the program for a minimum of 12 months to receive 12 months of benefits. The Company is simultaneously filing a separate advice letter with a similar request related to its Gas Affordability Program. The Company is not seeking an EAP funding increase or decrease. This filing has no net effect on the Company's annual revenues.

It is desired that the changed tariffs accompanying this Advice Letter become effective on May 16, 2024, on 30-days' notice.
