

**NOTICE OF REVISION TO THE GAS COST ADJUSTMENT
ON LESS THAN STATUTORY NOTICE
OF PUBLIC SERVICE COMPANY OF COLORADO
1800 LARIMER STREET, DENVER, COLORADO 80202-5533**

You are hereby notified that Public Service Company of Colorado (“Public Service”) has filed with the Colorado Public Utilities Commission (“Commission”), in compliance with the Public Utilities Law, an application for permission to revise its Gas Cost Adjustment (“GCA”) tariff on less than thirty days’ notice. The adjustment will become effective January 1, 2021, if said application is granted by the Commission.

The purpose of the revision in the GCA is to reflect a decrease in the forecasted costs of natural gas for the months of January, February and March 2021 and to adjust the deferred gas cost. The proposed revision to the GCA results in an estimated decrease of \$15,905,489 in Public Service’s revenue for the months of January, February and March 2021, when compared to the amount of revenue estimated using current GCA rates. The annual revenue resulting from the proposed first quarter 2021 GCA rates would be \$37,404,242 less than the annual revenue that would have been collected assuming the currently effective GCA rates for the fourth quarter 2020 were to be in effect for the period October 2020 through September 2021. A summary of the proposed revision to the GCA rates, by customer class, is provided below, and is applicable to all areas served by Public Service throughout the State of Colorado.

Anyone who desires may file written comments or objections to the proposed action. Written comments or objections shall be filed with the Commission, 1560 Broadway, Suite 250, Denver, Colorado, 80202-5143 or filed at www.dora.state.co.us/pacific/PUC/puccomments. The Commission will consider all written comments and objections submitted prior to the evidentiary hearing on the application if one is held. The filing of written comments or objections by itself will not allow you to participate as a party in any proceeding on the proposed action. If you wish to participate as a party in this matter, you must file written intervention documents in accordance with Rule 1401 of the Commission's Rules of Practice and Procedure or any applicable Commission order.

The Commission may hold a hearing to determine what rates, rules and regulations will be authorized. If a hearing is held, the Commission may suspend the proposed rates, rules or regulations. The rates, rules and regulations ultimately authorized by the Commission may or may not be the same as those proposed, and may include rates that are higher or lower.

The Commission may hold a public hearing in addition to an evidentiary hearing on the application. If such a hearing is held, members of the public may attend and make statements even if they did not file comments, objections or interventions. If the application is uncontested or unopposed, the Commission may determine the matter without hearing and without further notice.
