You are hereby notified that Public Service Company of Colorado ("Public Service" or the "Company") has filed with the Public Utilities Commission of the State of Colorado ("Commission") Advice No. 1954 – Electric to revise its Clean Energy Plan Revenue ("CEPR") in its Colorado P.U.C. No. 8 – Electric Tariff ("Electric Tariff") to become effective on January 1, 2025. The principal proposed change is to update the CEPR applicable to all charges for electric service including base Monthly Rates under the applicable Rate Schedule, Base Rate Adjustments and Non-Base Rate Adjustments and shall not apply to amounts recovered through the Renewable Energy Standard Adjustment ("RESA"), the Colorado Energy Plan Adjustment ("CEPA") and the Extraordinary Gas Cost Recovery Rider ("EGCRR"), to become effective January 1, 2025, in order to recover costs associated with clean energy plan activities in accordance with the Company's Clean Energy Plan approved by the Commission in Decision Nos. C24-0052 and C24-0161 in Proceeding No. 21A-0141E ("2021 Electric Resource Plan & Clean Energy Plan"), including the retail share of Production Tax Credit(s) or Investment Tax Credit(s) for CEPR-assigned resources, net of transfer costs, in accord with Commission orders. Consistent with the legislation, the Company is proposing a new charge for electric service calculated under the Company's total electric rates of 1.25% to recover the costs of clean energy plan activities

The effect of this filing upon the Company's annual revenue for the period beginning January 1, 2025 will be an increase of \$47,747,097. The proposed CEPR rate is 1.25% and is applicable to all electric service customers. The impact of the CEPR rates on the typical residential customer will be an increase of \$1.12 per month, or approximately 1.21%, based upon typical customer usage of 600 kWh. The impact of the CEPR rates on the typical small commercial customer will be an increase of \$1.47 per month, or approximately 1.18%, based upon typical customer usage of 910 kWh. Current and proposed total monthly CEPR bill impacts by customer class are shown in the table below.

The rates, rules and regulations ultimately authorized by the Commission may or may not be the same as those proposed and may include rates that are higher or lower.

The Commission may hold a public hearing on the filing. If such a public hearing is held, members of the public may attend and make statements even if they did not file comments, objections or interventions.
