## NOTICE OF PUBLIC SERVICE COMPANY OF COLORADO 1800 LARIMER STREET, DENVER, COLORADO 80202-5533 TO REVISE ITS PURCHASED CAPACITY COST ADJUSTMENT

You are hereby notified that Public Service Company of Colorado ("Company") has filed with the Public Utilities Commission of the State of Colorado ("Commission") Advice No. 1966 - Electric to revise its Purchased Capacity Cost Adjustment ("PCCA"), in its Colorado P.U.C. No. 8 - Electric tariff to become effective on January 1, 2025, if approved by the Commission.

The principal proposed change is to revise the PCCA, pursuant to the terms and conditions of the Company's PCCA tariff in P.U.C. No. 8 – Electric tariff, Sheet Nos. 141B through 141E, as approved by the Commission in Decision No. C06-1379, mailed December 1, 2006, in Proceeding No. 06S-234EG.

The effect of this filing on the Company's annual revenue will be a decrease of \$38,664,237 as compared to the 2024 PCCA currently in effect.

The \$38 million decrease from 2024 to 2025 is attributable to: (1) the change in the deferred balance from \$9,923,499 under-recovered as of September 30, 2023 to \$11,917,191 over-recovered as of September 30, 2024, (2) the removal of the Brush 1-3 capacity payments, and (3) a reduction to the Brush 4 capacity payments associated with outage activity in 2024.

The following table shows the current and proposed total monthly bill for each of the major rate schedules, assuming average usage and average demand.

The filing of written comments or objections by itself will not allow you to participate as a party in any proceeding on the proposed action. If you wish to participate as a party in this matter, you must file written intervention documents in accordance with Rule 1401 of the Commission's Rules of Practice and Procedure or any applicable Commission order.

The Commission may hold a hearing to determine what rates, rules and regulations will be authorized. If a hearing is held, the Commission may suspend the proposed rates, rules or regulations. The rates, rules and regulations ultimately authorized by the Commission may or may not be the same as those proposed and may include rates that are higher or lower.

The Commission may hold a public hearing in addition to an evidentiary hearing on the application. If such a hearing is held, members of the public may attend and make statements even if they did not file comments, objections, or interventions. If the application is uncontested or unopposed, the Commission may determine the matter without hearing and without further notice.
