NOTICE OF REVISION TO THE GAS COST ADJUSTMENT ON LESS THAN STATUTORY NOTICE OF PUBLIC SERVICE COMPANY OF COLORADO 3500 BLAKE STREET, DENVER, COLORADO 80205

You are hereby notified that Public Service Company of Colorado ("Public Service") has filed with the Colorado Public Utilities Commission ("Commission"), in compliance with the Public Utilities Law, an application for permission to revise its Gas Cost Adjustment ("GCA") tariff on less than thirty days' notice. The adjustment will become effective July 1, 2025, if the application is granted by the Commission.

The purpose of the revision in the GCA is to reflect a decrease in the forecasted costs of natural gas for the months of July, August, and September 2025. The proposed revision to the GCA results in an estimated decrease of \$2,686,975 in Public Service's revenue for the months of July, August, and September 2025, when compared to the amount of revenue estimated using current GCA rates. The annual revenue resulting from the proposed Third Quarter 2025 GCA rates would be \$35,986,989 less than the annual revenue that would have been collected assuming the currently effective GCA rates for the second quarter of 2025 were to be in effect for the period October 1, 2024, through September 30, 2025. A summary of the proposed revision to the GCA rates, by customer class, is provided below.

The Commission will consider all written comments and objections submitted prior to the evidentiary hearing on the advice letter if one is to occur. The filing of written comments or objections by itself will not allow you to participate as a party in any proceeding on the proposed action. If you wish to participate as a party in this matter, you must file written intervention documents in accordance with Rule 1401 of the Commission's Rules of Practice and Procedure or any applicable Commission order.

The Commission may hold a hearing to determine what rates, rules and regulations will be authorized. If a hearing is held, the Commission may suspend the proposed rates, rules, or regulations. The rates, rules, and regulations ultimately authorized by the Commission may or may not be the same as those proposed, and may include rates that are higher or lower.

The Commission may hold a public hearing in addition to an evidentiary hearing on the application. If such a public hearing is held, members of the public may attend and make statements even if they did not file comments, objections, or interventions. If the application is uncontested or unopposed, the Commission may determine the matter without hearing and without further notice.
