- My name is Ruth M. Sakya. I am a Manager, Regulatory Administration for Southwestern Public Service Company ("SPS"). My business address is 119 E. Marcy Street, Suite 202, Santa Fe, New Mexico 87505.
- I am over the age of 18 years, am of sound mind, and am fully competent to testify to all
  matters stated herein. I have personal knowledge of the facts stated herein, and they are
  true and correct.
- 3. I am a witness in SPS's pending base rate case, Public Utility Commission of Texas Docket No. 51802. The purpose of this affidavit is to update certain portions of the direct testimony that I provided in that case.
- 4. As I stated in my direct testimony, SPS's proposal to assign a value of \$0.86 per REC is based on average market prices of RECs between May of 2019 and early December of 2020. Since filing my direct testimony, REC prices have increased. See Exhibit 1 to this Affidavit, which is an update to Attachment RMS-RR-3. However, the average market price per REC remains close to \$0.86, even when computed with the increased REC prices. See id. Therefore, SPS does not change its proposal to assign a value of \$0.86 per REC.
