The principal proposed change is: to decrease the General Rate Schedule Adjustment ("GRSA") in the Company's Colorado P.U.C. No. 6 - Gas tariff, to become effective March 1, 2018, in accordance with Decision No. R18-0114-I (mailed on February 14, 2018) in Proceeding No. 17AL-0363G.

In compliance with Decision No. R18-0114-I the Company files this Advice Letter to decrease the GRSA from 33.64% to 28.41% as described in the Settlement Agreement On Impacts Of Tax Cuts And Jobs Act ("Settlement Agreement") filed by Public Service and Trial Staff ("Staff") of the Colorado Public Utilities Commission ("Commission") on January 19, 2017.

On June 2, 2017, the Company filed Advice No. 912 - Gas with supporting testimony and attachments, Proceeding No. 17AL-0363G ("Public Service's 2017 Gas Rate Case"). The advice letter and tariffs were suspended, and the matter was set for hearing. The evidentiary hearing was held on December 11 through 15 and 18, 2017. Shortly after the conclusion of the evidentiary hearing on December 22, 2017, the Federal Tax Cut and Jobs Act ("TCJA") was passed. On January 19, 2018, the Company filed the Settlement Agreement joined by Staff to address

the impacts of the TCJA in Proceeding No. 17AL-0363G. On February 14, 2018, Administrative Law Judge Conor F. Farley issued Decision No. R18-0114-I which requires the Company to file this advice letter and place into effect on March 1, 2018, revised provisional rates consistent with the Settlement Agreement that incorporate the Company's preliminary estimate of the impact of the TCJA. These revised provisional rates result in an annual revised reduction of \$20 Million and a revised GRSA of 28.41%.

Copies of this advice letter will be provided electronically to all parties in Proceeding No. 17AL-0363G. No additional notice is required.

The projected impacts of the Company's filing on typical monthly bills for 2018 are shown below.
