Incentive payments will be paid in one lump sum and the rest of the design team will then be paid by the Design Team Lead. Please note that multiple invoices and applications are not accepted. One incentive request should include costs for all design team work.

The design team incentive is a maximum dollar amount based on project square footage as determined below. Actual costs incurred by the design team may be greater or less than the available incentive. CenterPoint Energy will fund a portion of the design team incentive for projects that are participating in their EDA program. In these situations, you will receive one incentive check from Xcel Energy and another from CenterPoint Energy; the total amount will be up to what's listed below. You do not need to submit a separate application to CenterPoint Energy.

Requirements

Design team members are expected to participate in all Energy Design Assistance meetings plus participate in the following work efforts led by the EDA consultant for measurement and verification:

Bundle Requirement Document – The purpose of this report is to highlight the strategies identified in the selected bundle.

- **Action:** Project team is requested to provide construction documents, equipment specifications and product submittals/shop drawings for the bundled strategies.

Draft CD Review Report (Enhanced EDA only) – The purpose of this report is to compare the list of strategies identified in the Bundle Requirements Document to the strategies found in the requested CDs, specs and product submittals provided by the project team. A report, documenting the updated savings and incentive amounts will be provided.

- **Action:** Review the draft report. If there was information not provided on certain strategies initially, the project team is requested to provide additional information.

Draft Verification Report – The purpose of this report is to review and identify the strategies found on-site upon project completion. Updated savings and incentives are provided in this report based on verified findings.

- **Action:** Review the draft report. Any additional information not provided on certain strategies, will be requested from the design team.

Incentive application rules and process

- The design team incentive is available to architects, engineers and contractors participating in the Energy Design Assistance program.
- All incentives will be made in a lump sum payment not to exceed available incentive based on square footage after the final EDA meeting has taken place.
- This document is not an agreement between Xcel Energy and any parties listed above.
- Design team incentives are based on work requirements provided by participating in the Energy Design Assistance program. (see requirements section)
- Xcel Energy reserves the right to change or cancel this incentive program at any time.
- Companies receiving \$600 or more in trade incentives in a calendar year will receive a 1099 tax form for their payment.
- Incentives will be processed within four to six weeks of being received by Xcel Energy.
- Design team incentives for joint Xcel Energy and CenterPoint Energy projects are paid via separate checks from each utility.
- An approved design team incentive from Xcel Energy does not guarantee approval through CenterPoint Energy's incentive program.
