# New screw-in and pin-based lamp rebates added to Minnesota prescriptive program (started 7/1/22)


The Minnesota prescriptive rebate program now includes screw-in and pinbased lamps. The lamp rebates are also available in the Minnesota instant rebate program. If instant rebates do not work well for you and your customers, there is now another option—submit them through the prescriptive rebate program.

Note: If the same screw-in lamps are submitted through both channels, one application will get denied.

Rebates for Energy Star®-rated lamp types. Non-Energy Star lamp rebates are offered at 25% less.

#### **New Minnesota horticulture rebates (started 9/1/22)**

Xcel Energy now offers indoor grow lighting rebates for greenhouse applications. Rebates are \$.70 per watt installed for DLC certified units and 25% less for non-DLC. Photosynthetic photo flux rate for the equipment being installed must be noted on equipment specification sheet or invoice. This is available for retrofit and new construction.

## **New lighting controls specifications (started 9/1/22)**

Networked lighting controls now includes non-DLC equipment. If you are using multiple control strategies, including high-end trim, occupancy sensing, and daylight harvesting, rebate dollars are available at **\$.40 per controlled watt for both DLC and non-DLC equipment**. Additional equipment rebates are also offered. Standalone controls rebates are also available for single applications: occupancy, daylighting, and high-end trim.

## New 3-foot linear tube rebates (started 9/1/22)

Linear tube rebates are now available for retrofit applications for 2-, 3-, 4-, and 8-foot lamps. Rebates are based on the type A, B, or C designations. (Note: Submit 8-foot lamps as two 4-foot lamps.) **Bonus double rebates on linear lamps available through Nov. 15, 2022. Lamps do not need to be installed, just located on premises for when a lamp burns out.**
