

Activate your power by email or fax

Activate power to serve your new construction project by contacting our team by email or fax using the contacts on the right and the form on the back of this sheet. Submitting information well in advance of beginning your build will help facilitate a smooth activation.

Our team is ready to assist, but please remember:

- Commercial construction and all residential new homes, including manufactured, must obtain 911 addressing from their regional planning commission or emergency authority, found online and in local listings.
- Applicants for nonresidential construction in rural areas, where the local regional planning commission does not require 911 addressing, must supply Xcel Energy with accurate GPS coordinates, which can be obtained through sites such as Google, etc.
- Applicants for commercial construction in both rural and urban settings must attach a complete electrical schedule, including service entrance amperage and the size and quantity of the largest motors. If available, attach the plot plan or diagram identifying the proposed new structures and locations.
- Fill out contact information completely for the current person or entity responsible for the electric bill, including a cell number, email address and billing address.

Note: *New Mexico customers, please call 1-800-895-4999 after construction to see if you qualify for a special heating rate.*

THREE STEPS

- 1) Submit the new service application form by faxing or emailing the scanned form on the back. **Note:** *Not including PLAT or GPS coordinates may delay process.*
- 2) Secure building permits and inspections from the local authority. **Note:** *The cleared electric permits arrive direct to the Builders Call Line from local authorities. To check status of any permit you must call that authority.*
- 3) Begin construction, complying with Xcel Energy Design Engineering guidance. **Note:** *Rural home and commercial project contacts will be notified by Xcel Energy Design Engineering for availability and size of existing facilities after a service application has been accepted but before construction begins.*
