ENERGY STAR is an international standard for energy-efficient consumer products. Plus, with the Home Performance with ENERGY STAR program, you have the chance to earn \$710<sup>†</sup> or more in rebates when you implement three or more recommendations from your audit.

Our rebates will help you offset the initial cost of qualifying, energy-efficient products. And you'll likely see your return on investment right away, through lower energy bills.

Our Home Performance with ENERGY STAR program is ideal for homeowners who need to make multiple improvements to their home, such as adding insulation, a new, high-efficiency furnace or even an ENERGY STAR-certified thermostat.

## Home Performance with ENERGY STAR program in four steps

<b>Step 1</b>	<b>Get a Home Energy Audit</b> Choose a participating audit contractor or schedule a Home Energy Squad Plus visit. The program starts with a blower door test or infrared audit.
<b>Step 2</b>	<b>Choose a participating contractor</b> Have a participating Home Performance contractor install your recommended improvements. Only participating contractors may apply for Home Performance rebates.
<b>Step 3</b>	Have your contractor complete a post-improvement inspection, ensuring they complete the work successfully.
<b>Step 4</b>	Contractor will collect your receipts and submit rebate paperwork to Xcel Energy.

## Do you qualify?

- You must complete at least three improvements.
- You must be a combined residential gas and electric customer of Xcel Energy or an all electric customer with electric space heating.
  - Rebates are issued after the contractor verifies the improvements and submits the rebate paperwork. The average rebate per home is \$710.
  - You will receive your rebate check eight to 10 weeks from the paperwork being submitted.
