## NOTICE OF TECHNICAL DIFFICULTIES EXPERIENCED IN THE COMMISSION'S E-FILING SYSTEM

The Company hand delivered three paper copies of the ERP Application, which were accepted by the Commission initiating Proceeding No. 16A-0396E, however we were not able to e-file the remaining supporting documents.

The ERP (including all supporting testimonies and attachments and related pleadings) filed in accordance with Commission Decision No. C16-0127 in the above listed proceeding is the only electronic filing affected by this technical error.
